CONTRACT SUMMARY

Approve and authorize the County Judge to sign the letter to the Texas Indigent Defense Commission requesting a six-month, no cost extension of the FY 2018 Technical Support Grant #18-TS-08. (Contract No. 2019-0318)

ADDITIONAL BACKGROUND: The County received a grant in the amount of \$70,000 with a cash match of \$90,000 from County GF to evaluate the operations and impact on outcomes of their public defender's office, on of the oldes in the state and the indigent defense system. The grant period is twelve-months. The data extraction process took longer than anticipated, so the extension request is to allow for a full period to examine outcomes. The grant requires that a request to modify the term be signed by the County Judge.
