CONTRACT SUMMARY

Approve and authorize the County Judge to sign the Aliviane SAMHSA Services Agreement (Second Amendment - September 2019) with Aliviane Inc., and the DWI Drug Court Intervention and Treatment Program to provide counseling services to DWI Program participants in the amount of \$269,210 per year. This amended contract is effective beginning September 16, 2019 and will be awarded on an annual basis for up to five (5) years. Funding is available in SG-GSAMHSA19-OPERATING EXP. ADDITIONAL BACKGROUND: Aliviane Inc. will offer counseling services to the DWI Drug Court Intervention and Treatment Program participants that will create an individualized treatment plan for each participant to include Individual Therapy sessions, Group Therapy sessions, and others as outlined in Section III of the agreement. Contractor agrees and shall make it known that participation in a Twelve Step program is voluntary and must offer other options and materials to those who do not wish to participate in a Twelve Step program.

FISCAL IMPACT: Federal Funding: \$269,210 a year for each fiscal year (total of 5 years) starting FY2018.
