CONTRACT SUMMARY

Approve and authorize the County Public Works Department to apply to the Border 2020: US-Mexico Border Environmental Program for solid waste clean up events in the amount of \$99,225 with total match of \$87,550 for the period of January 1, 2020, through June 30, 2021. (Contract No. 2019-0799)

ADDITIONAL BACKGROUND: The Border 2020: US-Mexico Border Environmental Program for the County of El Paso, Texas will prioritize Goal #3 to **PROMOTE MATERIALS MANAGEMENT, WASTE MANAGEMENT and CLEAN SITES** with clean-up events. The goal of this project is to provide the County of El Paso's residents an opportunity to dispose of household hazardous materials, household trash, and tires which would otherwise be dumped and left in the desert areas of four unincorporated locations of the County. The locations are the Upper Valley, Westway, East Montana, Fabens and Las Colonias for a requested amount of \$99,225.00 and a match of \$ from 1/1/2020 to 6/30/2021.

FISCAL IMPACT: Match Labor Costs - \$20,400, Equipment - \$37,400 and Disposal of Household Trash \$29,750 = **TOTAL MATCH \$87,550.**
