GermBlast Pretreatment

Before a surface can be disinfected, it must first be cleaned. GermBlast staff utilize microfiber cloths in conjunction with a pretreatment chemical. GermBlast Pretreatment breaks through biofilm allowing for a more efficient sanitizing and disinfecting step.

GermBlast Spray

GermBlast Spray utilizes a rapid kill surface disinfectant. This powerful, hospital-grade disinfectant kills 99.999% of detectable pathogens. State of the art spraying systems help technicians achieve an efficient coverage. This GermBlast Spray modality is non-corrosive, non-toxic, and non-staining.

GermBlast Steam

GermBlast Steam offers a unique solution that allows an extremely high level of cleanliness while disinfecting the establishment, the dual purpose cleaning makes the process much more effective. A diverse assortment of pathogenic microorganisms can be rapidly killed by GermBlast Steam within 5 seconds. Risks of infection from contaminated surfaces will decrease further with more frequent treatments.

GermBlast PCO (Photocatalytic Oxidation)

GermBlast UV-PCO is one of the most effective air purification devices. It is capable of disinfecting over 60 harmful airborne pathogens including norovirus, tuberculosis, pneumonia, and influenza virus. UV-PCO creates a reaction between ultraviolet light and a titanium dioxide based catalyst in the presence of water that oxidizes and eliminates microorganisms circulating in the air.

GermBlast H2O2

GermBlast H2O2 utilizes a hydrogen peroxide and silver based disinfectant to eliminate the most robust microorganisms in an environment. This modality utilizes dry mist technology to atomize the disinfectant and distribute it throughout the environment ensuring complete coverage of an area from ceiling to floor. GermBlast H2O2 will not damage electronics or surfaces and breaks down into oxygen and water without leaving a residue.

GermBlast Shield

GermBlast Shield employs an innovative polymer that adheres to surfaces and inhibits odor-causing microorganism colonization, yet is safe to touch. The polymer is applied using electrostatic spraying technology that ensure 100% coverage by negatively charging chemicals, causing them to completely and efficiently cover every surface. Surface protection lasts for up to 90 days.
