ADDENDUM TO WEST AGREEMENT TERMS

- 2. Subscriber is a tax exempt political subdivision of the State of Texas that will not be liable for any taxes from which it is exempt.
- 3. Nothing referenced herein modifies or waives any sovereign immunity, lien or indemnity prohibition, defense, or limitation of liability enjoyed by Subscriber, its elected officials, or employees at common law or under other Texas law. Any indemnity provisions imposed on Subscriber in the Terms are deleted.
- 4. West acknowledges that funding to pay for support and services referenced herein is
 - subject to annual appropriations by Subscriber's governing body, and any termination, liability, indemnity, other provision to the contrary does not apply to Subscriber. In the event such funds are not appropriated in any fiscal year for support and services, Subscriber may terminate the Terms between the parties upon
 - no less than 30 days prior written notice without incurring any termination liability or penalty. Such termination will not affect Subscriber's obligation with respect to payment for satisfactory service or support received through the termination date.
- Subscriber is not liable under any circumstance for special, indirect, incidental, consequential, liquidated, or punitive damages of any kind, under any theory of recovery even if Subscriber is advised of the potential for any such damages.
- 6. Subscriber is subject to the Texas Open Meetings Act and Public Information Act, Chapters 551 and 552 of the Texas Government Code, respectively, which may require the disclosure of information despite any confidentiality, proprietary, or other provisions to the contrary in the Terms between the parties.
