## The ET3 Program

- UMC's Emergency Triage, Treat, and Transport (ET3) Program.
- Voluntary, five-year payment model that provides greater flexibility to ambulance care teams to address emergency health care needs of Medicare Fee-for-Service (FFS) beneficiaries following a 911 call.

## **EPCH Program Advancements**

### **Neurosurgery**

Since Pediatric Neurosurgeon Joined in May 2019, EPCH has seen an increase in neurosurgery and keeping our patients in El Paso for their Neurosurgery needs.

- May 18 April 19 94 Cases
- May 19 April 20 Increase 87.23% YOY
- May 20 present Increase 2.29% YOY

### **Cranial and Facial Clinic Visits**

- 2018 170 Visits
- 2019 Increase 16.47% YOY
- 2020 Increase 4.04% YOY

Food from the Heart is an initiative developed to help our Members put food on the table. During 2020 lockdowns many Members lost jobs, income, and the ability to buy enough food to feed their families.

## **Government Relations**

- Federal

## **Medicaid 1115 Waiver Extension**

- Initially approved in 2011; the current Waiver was set to expire September 30, 2022.
- Extension approval through September 30, 2030
- Potential of annual Medicaid expenditures of \$11.4 billion

- Maintains the Uncompensated Care (UC) Program currently at \$3.9 billion annually
  - Ability to resize in FFY2023
  - Ability for second resizing in Federal FFY2028


## **Medicaid 1115 Waiver Extension**

- New Directed-Payment programs, mainly the Comprehensive Hospital Increase Reimbursement Program (CHIRP) at \$5 billion annually for:
  - Delivery System Reform Incentive Payment (DSRIP) ending September 30, 2021 (currently \$2.5 billion annually)
  - Network Access Improvement Payment (NAIP) Program ending September 30,
     2027 for public hospitals (currently \$493 million annually)






## **Average Case Mix Index**









## **Average Length of Stay**









# 2020 Coronavirus Aid, Relief and Economic Security (CARES) Act



- Through December 31, 2020
  - UMC received \$42 million
    - Revenue recognition of \$30 million
    - Deferred revenue of \$12 million
  - El Paso Children's received \$21 million
    - Revenue recognition of \$9 million
    - Deferred revenue of \$12 million






October, November, December

# **District Vaccine Initiative**



### **District Vaccine Timeline**

- **November:** Texas convenes Expert Vaccine Allocation Panel (EVAP) to develop strategies as recommendations to the Texas Commissioner of Health.
- **December:** EVAP recommends front-line health care workers/residents of long-term care facilities as the first group (1a).
- **Dec. 14**<sup>th</sup>: Pfizer vaccine arrives in Texas.
- **Dec. 15**<sup>th</sup>: UMC starts vaccinating frontline hospital staff.
- Dec. 18<sup>th</sup>: UMC expands vaccine to all staff.
- **Dec. 21**<sup>st</sup>: UMC begins vaccinating other 1a community providers. Texas expands eligibility to include 65 and older, and 16+ with underlying medical conditions (Phase 1b)
- Dec. 23<sup>rd</sup>: EPCH starts vaccinating frontline hospital staff
- Dec. 28<sup>th</sup>: EPCH begins vaccinating other 1a community providers.
- Jan. 11<sup>th</sup>: State designates HUB's across the state. UMC is selected.
- Jan. 19<sup>th</sup>: UMC relocates vaccine effort to El Paso County Coliseum.







## **Super Seniors Priority**


- State of Texas urges all hub sites to set aside 20 percent of their vaccines for anyone 75 and older.





## El Paso vs. Other Texas Border Counties:








