Project Selection Criteria:

- -Projects from the prioritized list from Storm Water Master Plan.
- -Projects that have required repetitive responses from the Infrastructure Department staff (Road and Bridge).
- -Projects that have less environmental impacts.
- -Projects with access to County owned property to implement mitigation process.
- -Projects that will have a financial impact to the County.





Celeste Detention Basin Project



- -Obtain Consultant for Design Services
- -Prepare Design Documents

Project Concept:

Create a new detention basin north of Celeste Drive in order to reduce the amount of water flowing downstream of this area.

Project Concept:

This property sits at the end of an arroyo with no outlet. The project would construct a large centralized pond to capture all the water that is flowing into this arroyo creating a safe location to collect the storm water running off of the Mountainside.




Chicken Farm Basin Project

Milestone Actions:

- -Obtain Consultant for Design Services
- -Obtain Permits
- -Prepare Design Documents
- -Bid Project
- -Obtain Contractor to Build Improvements

Project Concept:

This collection pond would capture all the alluvial fans coming off of the mountain and desilt the materials and transfer into the newly constructed chicken ranch channel as part of fy20 projects.

- -Construction Phase: 9-12 Months
- -Closeout Phase: 3-5 Months
