CONTRACT SUMMARY

Approve and authorize the County Judge to sign the Interlocal Agreement For The Provision Of Multi-Systemic Therapy (MST) Services Between El Paso County and El Paso MHMR d/b/a Emergence Health Network, for children and adolescents under the care of a referring agency and who may be candidates for mental health therapy, from October 1, 2021, through September 30, 2022 in an amount not to exceed \$238,425. Funding is available in GF-JPD-PROF SVC-GEN and SR-JPDSUP-PROF-SVC-GEN. (Contract No. 2021-0541)

ADDITIONAL BACKGROUND:

The Juvenile Probation Department may refer candidates for MST with the understanding that not all candidates referred will receive MST, and that EHN has the sole discretion to accept any or no referred candidates for MST. To the extent allowable under applicable federal and state privacy and confidentiality laws, the parties agree to exchange information for the exclusive purposes of providing MST. Both parties agree to undertake to resist in judicial proceedings any effort to obtain access to information pertaining to clients otherwise than as expressly provided for in the Confidentiality Regulations. On a monthly basis, EHN shall provide status reports to JPD regarding disposition of the referral; EHN shall maintain documentation of services.
