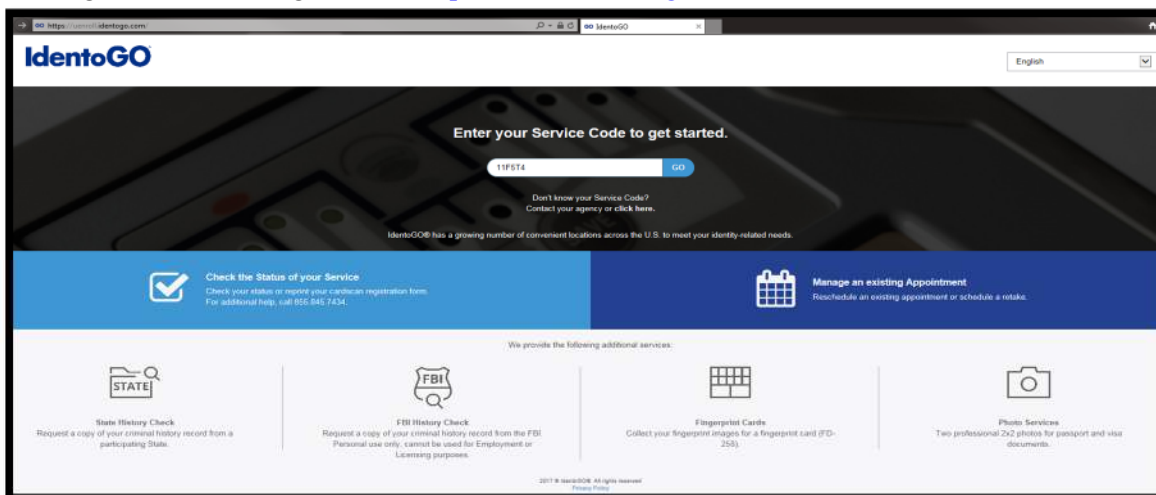

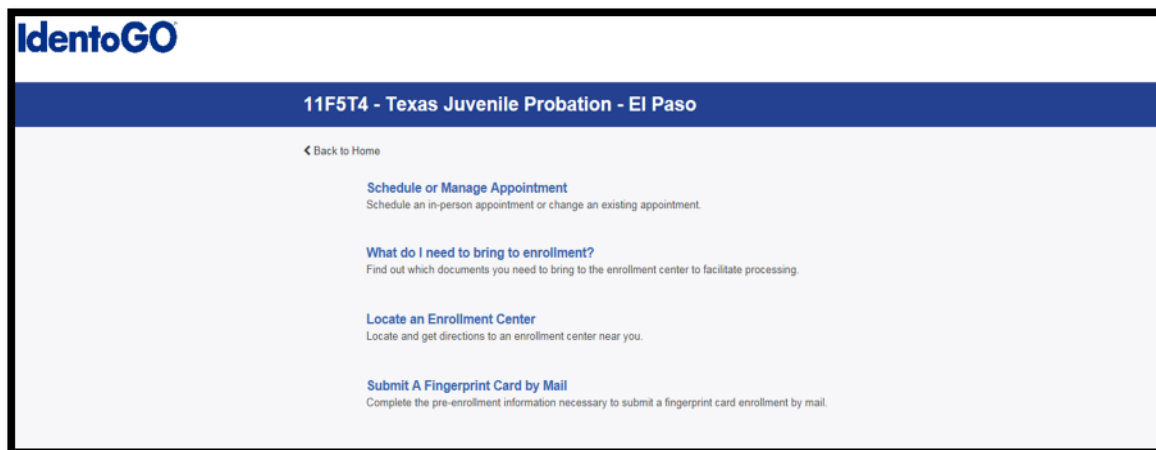


2. Enter the following service code: **11F5T4**
