

INTRODUCTION

The Veterans Advisory Board was approved by the El Paso County Commissioners Court on September 28, 2015, to serve as a link between the Veteran community and El Paso County government. The initiative was a culmination of collaborative efforts between Commissioners Leon and Stout and local Veterans advocates.

During the January 2018 El Paso County Commissioners Court strategic planning session, an action was presented to clearly define the current purpose of the Veterans Advisory Board. This was completed through developing a Veterans Advisory Board Directive, with updated and specified responsibilities and guidelines.

VISION

El Paso County Veterans and their families' needs met through access to available food, housing, employment, education, mental health, medical, and financial resources.

MISSION

Identify Veterans services gaps throughout El Paso County and propose recommendations to the Commissioners Court to improve quality of life for Veterans and their families.

PURPOSE

The purpose of the El Paso County Veterans Advisory Board is to inform the Commissioners Court of Veterans' affairs, identify services shortfalls and propose recommendations for approval and action.

QUALIFICATIONS

- Received honorable discharge or spouse of honorably discharged Veteran.
- Demonstrate proficiency in Veterans' matters throughout El Paso County.
- Coordinate Veteran community support.
- Dedicate requisite time and effort.

TERM

- Board members are appointed for a two-year term with no term limit.
- Participants can be dismissed by the Commissioners Court without justification.
- Removal of a board member is permitted with a majority vote from fellow participants for conduct not in harmony with the Commissioners Court or El Paso County representative.
- Board members can resign their position at any time.
- In the event of a vacancy, the corresponding Commissioners Court will appoint a new board member to either serve the remainder of the unexpired term or commence a new term.

RESPONSIBILITIES

- 1. Collaborate with Veterans and Veterans' advocates throughout El Paso County to identify gaps accessing assistance and resources for Veterans and their families.
- 2. Attend Veterans Advisory Board Meetings and introduce, discuss then examine problems.
- 3. Develop a plan to resolve identified issues using collective board member experience, community stakeholders, and already established resolutions.
- 4. Seek solutions utilizing accessible, existing community resources first and account for all projected County obligations prior to finalizing plans and proposals.
- 5. As required, coordinate with the El Paso County Veterans Assistance Office to add discussion and approval items to the Commissioners Court Regular/Special Meeting Agenda.
- 6. Communicate regularly with appointing Commissioner/County Judge to discuss Veteran concerns, topics, and updates.
- 7. Assist coordinating Veterans community support and obtaining assistance.
- 8. Develop a Veterans Affairs policy for the County of El Paso.
- 9. Complete an annual report of the board's activities to be presented to the Commissioners Court, no later than June 30 of every year.
