FIRST AMENDMENT TO THE AGREEMENT BETWEEN THE EL PASO COUNTY JUVENILE PROBATION DEPARTMENT AND ALCOHOL MONITORING SYSTEMS, INC.

On the 27th day of January 2022, the County of El Paso Juvenile Probation Department, Texas (hereinafter referred to as "JPD") and ALCOHOL MONITORING SYSTEMS, INC. ("AMS"), a Delaware corporation located at 1241 West Mineral Avenue, Suite 200, Littleton, Colorado 80120, henceforth collectively referred as the "Parties", entered into a Master Agency Agreement with Product and Service Schedule (2021-0957) attached hereto and made a part of hereof for all purposes. The Parties now desire to amend the Agreement for good and valuable consideration specified herein. All sections of the Agreement not specifically amended herein shall remaining full force and effect.

WHEREAS, the original agreement did not contain a clause addressing ANNUAL PRICE ADJUSTMENTS, NOW THEREORE it is mutually understood and agreed by and between the undersigned contracting parties to amend the previously executed Agreement.

3.1.5 ANNUAL PRICE ADJUSTMENT. After the first twelve (12) months of the Initial Term, AMS reserves the right to increase the pricing specified on the accompanying Product and Services Schedule by the yearly percentage increase in the Consumer Price Index for all urban consumers as issued by the Bureau of Labor Statistics of the U.S. Department of Labor ("CPI") as reported for each September (as measured by the increase in the CPI from September of the prior year) ("Annual Price Adjustment"). AMS will notify Agency of any such Annual Price Adjustment for the following calendar year by October 1 of the prior year, and such percentage increase will become effective as of January 1 of the following year.
