Eligible organizations providing shelter, food, transportation, basic heath and first aid, COVID-19 testing and associated medical care needed during quarantine and isolation, and other supportive services may apply for funding.

Not Applicable. The COEP has not been the direct services provider therefore operational planning is not required. COEP Planning and Development has contracted Project Amistad, they are the direct service provider.

Yes, in 2019 the COEP applied for EFSP Humanitarian Relief funds. COEP received reimbursement funding for submitted expenses. In October of 2021, the COEP Applied for reimbursement for cost incurred during the 3 rd quarter (March 1st		
through September 30 th). Award was received on 02/28/2022 (2022-0093). Commissioners Court Approved the agenda item to accept the funds.

For this Application Period, we are seeking reimbursement for \$55,440.00 for cost incurred between April 1- June 30, 2022.

4) What is the sustainability plan for this grant and the services being provided if this funding is significantly reduced or is not awarded in future? Not Applicable. This grant application for reimbursement is not expected to be ongoing. A sustainability plan was not mapped out because this service was in response to the urgent need for transportation for the influx of migrants coming through our border. The COEP will be seeking reimbursement for humanitarian relief assistance it provided/has been providing through contracted services with Project Amistad. **PROGRAMMATIC ASSESSMENT** 1) Is this grant and its purpose(s) aligned with the County strategic plan? How will this grant benefit your department/division and communities in El Paso County? Yes, the humanitarian support that the COEP has been providing aligns with the County's Strategic plan to 1) Promote Collaboration and Engagement and 2) Advance Community Support Services. The contracted transportation service trough Project Amistad allows for continued and expedited movement of migrants in our region being released directly by DHS to Annunciation House. This collaboration and support allows for rapid processing and movement of migrants to other parts of the nation and to mitigate COVID-19 spread in our region. 2) Please explain the capacity of your department/division to administer this grant and complete all programmatic reporting requirements during the grant period. The COEP Planning and Development is overlooking the transportation contract with Project Amistad. Amistad is coordinating migrant transport closely with Annunciation House. Project Amistad has been billing the County on a monthly basis for services provided. Office of New Americans with the Community Services Department, has been liaising communication between parties and is compiling reports and forms needed for this reimbursement application. 3) Will this grant require the use of contractual services? If so, please contact the Purchasing Department, upon award acceptance to ensure your department is in compliance with applicable procurement policies and procedures. Yes, the COEP has contracted transportation services with Project Amistad. Original Agreement 2020-0368, Amendment 1 2021-0154, Amendment 2 2021-0217, Amendment 3 2021-0469, Amendment 4 2021-0999, Amendment 5 2022-0431 (Pending legal review and CC approval) Due to the County and State emergency declaration because of COVID-19 and to preserve and protect the public health and safety, the County used its statutory authority under Sec 262.024 of the Local Government Code which provides the Commissioners Court discretionary exemptions from the competitive bidding process to retain the professional services of Project Amistad for the transportation of migrants.
