### **ADDITIONAL BACKGROUND:**

Provisions of the ARPA law (Public Law No: 117-2) provides funding to the FEMA Emergency Food and Shelter Program (EFSP) to help defray the costs that local governments have incurred in providing humanitarian assistance to families and individuals encountered by the Department of Homeland Security (DHS). The County applied for reimbursement for transportation costs incurred during the 4th quarter of the grant (October 1, 2021 – December 31, 2021).

This agenda item is to accept the 2021 4th quarter FEMA EFSP award of \$27,504.
