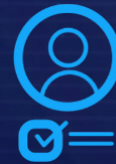

Pricing

Timeline

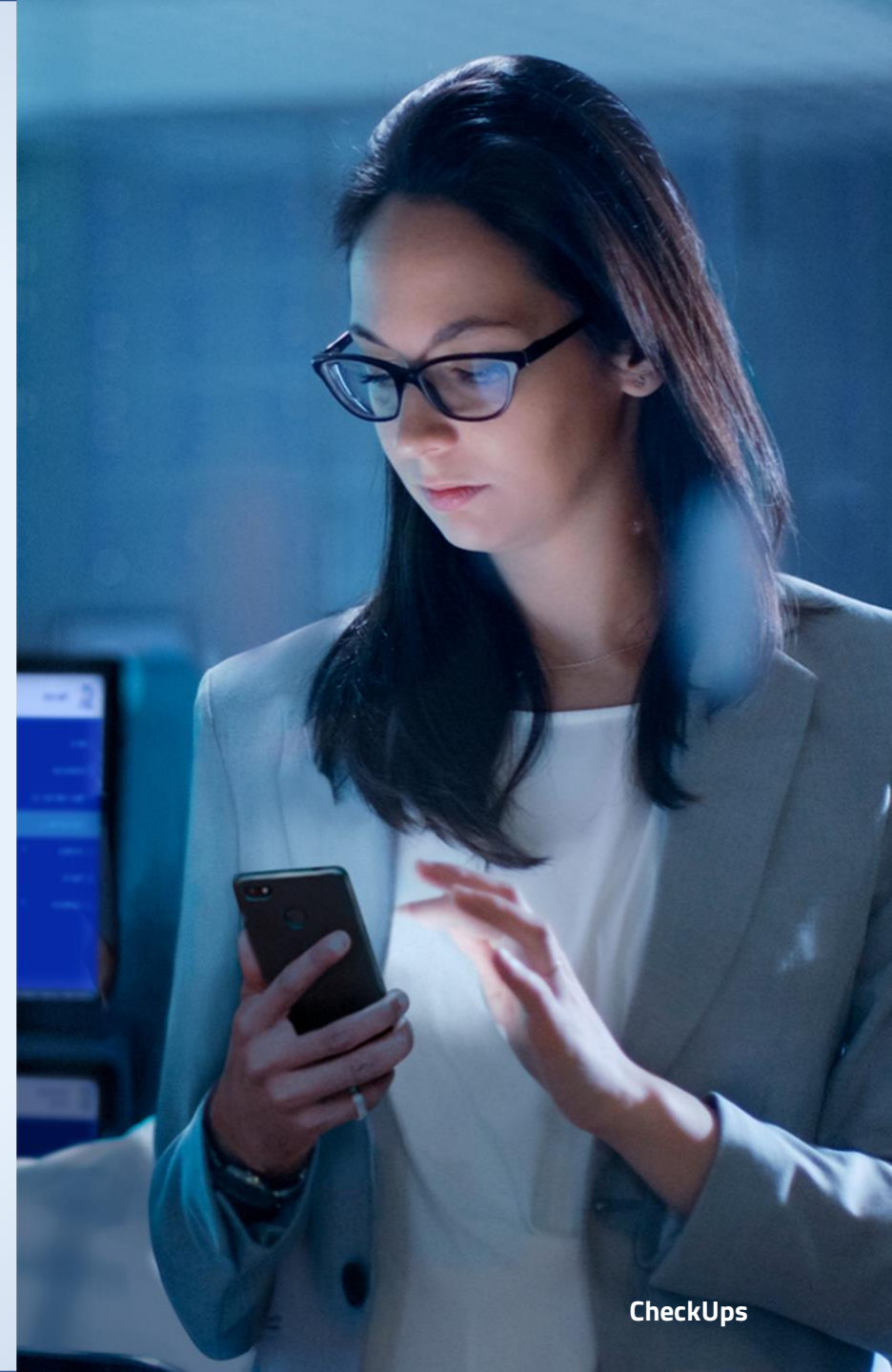
Upon confirmation, CheckUps will begin platform setup process and training session within two weeks.
