ADDITIONAL BACKGROUND: The actuarial consulting services agreement was approved by Commissioners Court on 08/20/2018 for fiscal years 2018 & 2019. The 1st amendment was approved on 06/15/2020 for fiscal years 2020 & 2021. The actuarial study is required pursuant to GASB 75, Accounting and Financial Reporting for Post-employment Benefits Other Than Pensions.
