

- Attorneys provide legal modification & enforcement of Child Support/ Medical and Dental Support and modification & enforcement of Access and Possession orders.



The primary goal of Community Supervision is to monitor parents who are placed on probation and assist them in becoming compliant with their family court order.


- We have collected \$1,423,760.10 in child support from individuals placed on Community Supervision
- Projected revenue from OAG contract for IV-D Community Supervision cases for 2022: \$88,902.67

Community Supervision – Over 16,000 Activities





 - Phone Calls




CHILD SUPPORT ENFORCEMENT

The Child Support Enforcement division accepts applications for IV-D services from individuals with existing court orders from El Paso County that include Child Support. Our services include:


- Generate Child Support pay records
- Modification and Enforcement of Child Support, Medical Support, and Dental Support provisions as spelled out in court orders.
- Send out modification review questionnaires
- Open cases at the State Disbursement Unit for the processing of payments
- Following the latest federal child support guidelines, we now provide the ability to pay questionnaires before proceeding with contempt enforcement actions.




Child Support Enforcement –\$17 Million in Collections

Family Court Services provides court-ordered social services to help families resolve family law disputes out of the courtroom.

\$59,730 annual grant with the Office of the Attorney General (OAG) to provide Access and Possession services at no cost to individuals with existing IV-D Child Support Cases. We will have an additional term in 2023-2024.
