SCOPE OF WORK

GENERAL:

This proposal provides for warm-up and screening areas for the sports park. Work includes a new Irrigation system and new Bermuda grass installation, screening rock installation. This project will be phased as required to accommodate the center business and traffic

1.0 SCOPE OF WORK:

In accordance with this scope of work all labor, materials, supervision, equipment, insurances, taxes, overhead, and all other things or services necessary to install components and systems to provide for the renovation of the affected areas as indicated herein.

Work includes but is not limited to the following:

1.1 Scope:

- 1) Remove and kill existing weed at the areas where grass and landscape rock will be installed
- 2) Distribute and level existing ground
- 3) Install new irrigation system for new Bermuda grass
- 4) Install 17,500 sq ft of new Bermuda grass
- 5) Install 28,000 sq ft of weed barrier
- 6) Install 28,000 sq ft of screening rock
- 7) Install 1150 lf of Edging- Brown A
- 8) Final Cleaning
