# CONTRACT SUMMARY

Approve and authorize the Stop Loss Renewal Proposal Rate with Aetna Life Insurance Company for Stop Loss Insurance coverage for the County's Health and Dental Plan for plan year 2024. Funds are available in account: IS-HEALTH-SPECF/AG STP LSS INS. (Contract No. 2023-0874).

### ADDITIONAL BACKGROUND:

On December 3, 2018, the County of El Paso awarded a bid to Aetna Life Insurance Company to serve as the County's Third Party Administrator (TPA) for Health and Dental Benefits. Included in the Aetna's bid was the ability for the County to obtain Stop Loss Insurance through Aetna Life Insurance Company. The purpose of Stop Loss Insurance is to protect the Risk Pool Fund from catastrophic individual claims over \$300,000.

Over the past six years, the County's Risk Pool Fund has experienced on average between 5 to 6 stop loss claims. This year between January and September 2023, the County's Risk Pool Fund has experienced four Stop Loss Claims in excess of \$300,000.

The attached Stop Loss Renewal Proposal Rate from Aetna Life Insurance Company maintains a \$300,000 deductible without any members who would require a separate deductible (no lasering). This renewal would increase premiums costs from \$3,081,245 to \$3,379,765 (\$298,520 estimated annual increase).

The County's Risk Pool Board has recommended approval of the Stop Loss Renewal Proposal Rate during their regular meeting on November 15, 2023.

Approval of this renewal proposal rate will result in the creation of formal insurance policy which will be brought back to the Commissioners Court for final approval.

The Stop Loss Renewal Proposal Rate with Aetna Life Insurance Company for Stop Loss Insurance for the County's Health and Dental Plan for plan year 2024 has been reviewed by the County Attorney's Office. (2023-0874)
