

CONTRACT SUMMARY

A County Match in the amount of \$16,276.07 is required and will be met through an existing salary, for a total grant amount of \$66,266.07. (Contract No. 2023-0967.)

ADDITIONAL BACKGROUND: In an effort to reduce the traffic fatalities caused by drunk drivers, provide the El Paso community an alternate to not driving home intoxicated, by providing an opportunity to obtain alternative transportation, ride share, at no cost or minimal cost to them.
