

**THIRD EXTENSION TO GUARDIANSHIP SERVICES AGREEMENT**

This Third Extension to Guardianship Services Agreement (“*Third Extension*”) is by and between the County of El Paso, Texas, a political subdivision of the State of Texas (“*County*”), and Project Amistad, a Texas non-profit corporation (“*Contractor*”). Each of the County and the Contractor may be referred to herein as a “*Party*” or, collectively, as the “*Parties*.”

**RECITALS**

**WHEREAS**, the Parties entered into a Guardianship Services Agreement, dated effective January 1, 2020 (Contract No. 2019-0881), with an initial term of two-years and the option to renew for three additional one-year terms; and

**WHEREAS**, the Parties exercised the first renewal option and executed a First Extension to Guardianship Services Agreement, dated effective January 1, 2022 (Contract No. 2022-0233), and the second renewal option with a Second Extension to Guardianship Services Agreement, dated effective January 1, 2023 (Contract No. 2023-0023) (Contract No. 2019-0881, 2022-0233, and 2023-0023, collectively, the “*Agreement*”); and

**WHEREAS**, the Parties now desire to exercise the third and final renewal option and to amend certain provisions of the Agreement.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows.

**AGREEMENTS**

**1. Term.** The Parties agree to exercise the third and final option to renew the term of the Agreement. The last renewal term shall commence on January 1, 2024, and expire on December 31, 2024.

**2. Compensation for Services.** Exhibit C of the Agreement is deleted in its entirety and replaced with the Compensation for Services exhibit attached to this Third Extension.

**3.** All other terms and conditions of the Agreement not amended herein shall continue unchanged and in full force and effect. In the event of any conflict between the Agreement and this Third Extension, this Third Extension shall control.

**IN WITNESS WHEREOF**, the Parties have executed this Third Extension to be effective as of the Effective Date.
