SECOND EXERCISE OF OPTION TO RENEW AGREEMENT

On the 14th day of January, 2013, the County of El Paso, Texas ("Site Owner"), and WSILC, L.L.C., dba Welch ATM ("WSILC") an Illinois Limited Liability Company, entered into an ATM Placement Service Agreement ("ATM Agreement"). On July 8, 2013, Site Owner and WSILC first amended the ATM Placement Service Agreement. As a result of a merger, WSILC L.L.C. assigned its interest in this ATM Agreement to Cardtronics USA, Inc. (Cardtronics). Pursuant to the ATM Agreement, paragraph 16, this Agreement remains enforceable as to Site Owner and Cardtronics, as the successor and assign of WSILC L.L.C. On March 7, 2016, Site Owner and Cardtronics amended the Agreement a second time. Thereafter, on February 5, 2018, the parties renewed the Agreement for a three year term.

The parties now desire to exercise their option to renew the Agreement for a second three year term as allowed by paragraph 11 of the Agreement.

- 1. The Agreement has options to renew for three year terms. This renewal period will begin February 1, 2021 and expire on January 31, 2024.
- 2. Exhibit A is deleted in its entirety and replaced with the attached Exhibit A.

All other terms and conditions of the Agreement, including amendments and renewals, remain the same. The ATM Agreement and its two amendments and first renewal are fully incorporated herein and together with this renewal comprise the entire agreement between the parties.
